Mrs. Lawrence presented the Sherman Economic Development Corporation Investment Policy, highlighting the changes that included clarifying the handling of certificates of deposit. Motion to approve was made by Mr. Sild and seconded by Mr. Steele. Motion was approved unanimously.

Mr. Plotnik recommended an Addendum to the Sherman Economic Development Corporation Economic Development Performance Agreement for Ball, DPF to amend section 7.1 of the Agreement ("Payments") and section 10.14 of the Agreement ("Term") to extend the Agreement from the original ending date of November 1, 2016 to May 1, 2017.

Motion to approve the Addendum to the Economic Development Performance Agreement with Ball, DPF was made by Mr. Douglass and seconded by Mr. Sild. Motion was approved unanimously.

ECONOMIC BAROMETER REPORT (September 2016)

Mr. Plotnik referred to the EBR report in the board packet and noted the number of new residential building permits was down 15% from year-to-date 2015, and three new multi-family building permits had been secured from year-to-date 2015.

Mr. Plotnik noted the Overall Commercial and Industrial Permits were up 8% and calls from retail site selectors were a great indicator that positive retail sales are making a difference.

NTRA MANAGEMENT UPDATE

Members reviewed the North Texas Regional Airport Management Update for August and September 2016. Sarah Hinton was named the Director in August.
