FINANCIALS

Ms. Lawrence presented the financials for the quarter ended December 31, 2015 and noted that the net fund balance is \$6.2 million, with \$9.5 million in outstanding commitments as detailed on the Incentive Schedule.

Ms. Lawrence presented the Investment Report for the quarter ended December 31, 2015 and noted that the weighted average maturity is 92 days.

ECONOMIC BAROMETER REPORT (January 2016)

Mr. Gadek referred to the EBR report in the Board packet and noted that Sherman's sales tax is at a 5.49% change since January 2015, and as of December 2015, Sherman's unemployment rate is 3.7%.

PRESIDENT'S REPORT (February 2016)

Mr. Plotnik presented the updated FY 2015-2016 Completed Projects and Signed Agreements and referred to the report in the Board packet and discussed the following:

Project Information:

SEDCO is presently working on 21 active projects with an estimated \$611,750,000 in investments and approximately 3,638 new jobs.

SEDCO Operations/Administration:

A "First" for Sherman was the ground breaking of a new 60,000 square foot industrial building within the Midway Industrial Park. This building will offer industrial space that is presently not available within our community.

SEDCO's 20th Anniversary Celebration is slated for April 25th from 4:00-6:00 p.m. at the Finley Reception Room.

Executive Vice President, Frank Gadek is preparing to attend the Industrial Asset Manager's Council (IAMC) Spring 2016 Professional Forum. This conference is attended by target companies, site selectors, and consultants.

Business Retention/Expansion Program:

In January, SEDCO visited Panda Sherman Power, Panda Power Funds, Royal Case, and Ya-Hoo! Baking Co.

SEDCO also hosted a Sherman Safety Leaders Forum with the following key employers in attendance: Douglass Distributing, GlobiTech, Kaiser Aluminum, Nature's Source, Plyler Construction, Presco Products, Sunny Delight, Texas Instruments, and Washington Iron Works.

The February 2016 President's Report included a company spotlight over Washington Iron Works.
