ECONOMIC BAROMETER REPORT (February 2016)

Mr. Plotnik referred to the EBR report in the Board packet and noted that the City Building Permits Value is at a 95.85% change from February 2015, and as of January 2016, Sherman's labor force is 19,252 and the unemployment rate is 3.9%.

PRESIDENT'S REPORT (March 2016)

Mr. Plotnik presented the updated FY 2015-2016 Completed Projects and Signed Agreements and referred to the report in the Board packet and discussed the following:

Project Information:

SEDCO is presently working 21 active projects with an estimated \$336,000,000 in investments and 2,513 new jobs.

SEDCO Operations/Administration:

SEDCO has entertained four site tours and placed in escrow a 37 acre tract of land in Progress Industrial Park with the J.P. Hart Lumber Company, who will be manufacturing wood products for the residential industry.

Business Recruitment:

Over the past month, SEDCO had four site tours from companies interested in a possible location within the Sherman community.

SEDCO staff made three visits to key companies to discuss Sherman's assets. In addition, SEDCO hosted six visits from these professionals interested in learning more about our community.

Executive Vice President Frank Gadek is preparing to attend the Industrial Asset Manager's Council (IAMC) Spring 2016 Professional Forum.

Business Retention/Expansion Program:

In February, SEDCO visited with key leadership from Capio Partners, FedEx Freight, Tyson, Sunny Delight, Consolidated Container, Starr Aircraft, Washington Iron Works, Ball, DPF, Emerson Process Management/Fisher, and West.

SEDCO held a Sherman Plant Manager's Forum hosted by Emerson Process Management/Fisher with the following key employers in attendance: CertainTeed Corporation, Christmas Designers, Douglass Distributing, EATON B-Line, Kaiser Aluminum, Panda Sherman Power, and Progress Rail Services.

Incentives & Compliance:

In February, SEDCO completed the following Economic Development Performance Agreements:

SEDCO will provide Anutak Products, Inc., a manufacturer of flexible duct for air conditioning and heating systems, a \$25,000 incentive towards a \$300,000 investment in the operation of a new manufacturing facility at 1400 West FM 1417, as well as the creation of 11 full-time jobs.

SEDCO will provide Ball, DPF/Nature's Source a \$7,965 incentive towards a \$159,300 investment in the renovations of the tank farm, as well as the creation of one full-time job.

The March 2016 President's Report included a company spotlight over Tyson.

Mr. Hefton discussed plans for a joint City Council meeting in April between the City of Sherman and the Sherman Independent School District, and he mentioned including SEDCO in a future joint meeting.
