## CALL TO ORDER, QUORUM DETERMINED, MEETING DECLARED OPEN, RECOGNITION OF GUESTS AND VISITORS

Mr. Kirkpatrick, Chairman of the Sherman Economic Development Corporation, called the meeting to order at 7:30 A.M., declared a quorum present, meeting declared open, recognition of guests and visitors.

# RECONVENE OPEN MEETING AND CONSIDER ITEMS DISCUSSED IN EXECUTIVE SESSION Mr. Kirkpatrick reconvened the open meeting at 7:43 A.M.

Mr. Plotnik recommended the approval of a Sherman Economic Development Corporation Economic Development Performance Agreement with Cooper B-Line, Inc. (Eaton). The agreement states that Eaton will invest \$493,500 in facility improvements and new equipment at its facility at 4900 Marshall Street; and SEDCO will provide an incentive of \$24,675 upon proof that the conditions have been met.

Motion to approve the Economic Development Performance Agreement with Cooper B-Line, Inc. (Eaton) was made by Mr. Sild and seconded by Mr. Shields. Motion was approved unanimously.

### **ECONOMIC BAROMETER REPORT (March 2017)**

Mr. Plotnik presented the Economic Barometer Report and noted the following: New Residential building permits are up 150% in comparison to March 2016; total city building permit values are up 52.13% from YTD 2016; and Sherman's unemployment rate is 4.1%.

#### PRESIDENT'S REPORT (April 2017)

Mr. Plotnik presented the following April 2017 President's Report:

#### **Project Information**

SEDCO is presently working 17 active projects with an estimated \$961,893,500 in investments and 2,014 new jobs.

#### SEDCO Operations/Administration

Well, Spring Break is over and Sherman is getting back to work after taking a big collective breath. SEDCO continues to market Sherman within the region and state-wide, and now we are expanding even further as we visit our target companies and attend national and international conferences. In addition, we started the plan for improvements to Progress Park, including the project to extend Northgate Drive to the new West Travis Street extension. 2017 has been busy for SEDCO, and it appears the trend will continue as we are responding to new projects each week and hosting site visits each month. Sure, we won't get all the projects, but we will work as though we own them all.

This weeklong event was created to increase awareness for local programs that create jobs, advance career development opportunities, and increase quality of life. #### **Business Recruitment**

Since our last report, we have hosted three site visits and spoke with 24 site selectors, consultants, and real estate professionals interested in Sherman.

On April 8th-12th, Frank Gadek attended the Industrial Asset Management Council (IAMC) Spring Forum in Tampa, Florida. This year's forum focused on Industrial Real Estate in the 21st Century. SEDCO co-hosted of a private dinner for approximately 30 site selectors. This dinner provides a great opportunity for one-on-one conversations with those individuals looking at Sherman for their projects' next location.

## **Business Retention/Expansion Program**

Existing industry visits are critical. Our ongoing program will not only move toward increased relationships with our corporate citizens but is also a valuable resource for referrals within their respective industries. An HR Group Meeting was held on March 30<sup>th</sup>, and representatives from the following companies were in attendance: CertainTeed, Emerson-Fisher, Presco and Sunny Delight.

Brian Aspell of Champion Coolers asked for, helped develop and has a passion for the Industrial Maintenance Technology (IMT) program. He presented the program to the Sherman High School juniors and inspired 25 students to learn more. On April 6<sup>th</sup>, those students toured the IMT Lab at Grayson College, and the instructor, Shawn Hendricks, described the program and showed the students the hands-on aspect of the classes.

On April 29<sup>th</sup>, SEDCO attended the High Demand Job Training Grant Check Presentation at Workforce Solutions Texoma. SEDCO and DDA each provided \$50,000 to match the Texas Workforce Commission's \$100,000 grant, which will go towards equipment for the Advanced Manufacturing Program at Grayson College. This program provides high school students the opportunity to earn a certification and college credit before graduation.

#### **BUSINESS RETENTION & EXPANSION UPDATE**

Mrs. Jones discussed the upcoming Career Connections job fair scheduled for April 13<sup>th</sup> at the Hilton Garden Inn. The event is sponsored by the Sherman Economic Development Corporation, Denison Development Alliance, Workforce Solutions Texoma, Grayson College, Texas Veterans programs and Texas Workforce Solutions. Participation is expected from seven Sherman manufacturers and three call centers: Eaton B-Line, Progress Rail, Tyson Foods, Presco Products, Emerson, Royal Case, Mueller Construction, Capio, TALUS Payments and Alorica.

Mr. Plotnik shared the March 2017 North Texas Regional Airport Management Update report and noted the nine prospects interested in NTRA's existing buildings and available sites for building hangar and office spaces.

Councilman Steele noted that the job titles of the employees who were involved in the layoff at Zodiak in Gainesville have been forwarded to our local industries.
