Motion was made by Mr. Sild and seconded by Mr. Steele to approve the regular scheduled meeting minutes of June 9, 2015 and the Special called meeting minutes of June 30, 2015. Motion was approved unanimously.

FINANCIALS

Ms. Lawrence presented the financials for the month ended May 31, 2015; the net fund balance was \$7.7 million with \$8.6 million in commitments spread over several years.

Motion to approve the financials for the month ended May 31, 2015, was made by Mr. Steele and seconded by Mr. Kirkpatrick. Motion was approved unanimously.

BRAND AND WEBSITE PRESENTATION BY HCK2

The HCK2 team Ms. Capps, Mr, Kirby, Ms. FitzGerald and Mr. Wilson discussed the marketing work they have completed for SEDCO since summer 2014. They explained the creation of the brand and website design highlighting functionality and ease of in house maintenance.

RECONVENE OPEN MEETING AND CONSIDER ITEM DISCUSSED IN EXECUTIVE SESSION Mr. Hull reconvened the open meeting at 1:55 P.M.

Mr. Gadek proposed a Performance Agreement with Panda Sherman Power II, LLC. Panda Sherman Power II plans to develop, construct and operate an approximately 450 megawatt, natural gas fired, combined cycle, electric generation power plant. The project proposes to add \$200 million additional value to the tax rolls. SEDCO will convey by grant a total of \$2,500,000 to be paid in three increments. The contract will expire on April 1, 2019.

Motion to approve the Panda Sherman Power II, LLC Performance Agreement was made by Mr. Steele and seconded by Mr. Kirkpatrick, two in favor, one opposed. Motion approved.

- Emerson Process Management-Fisher Controls Company indicates the construction of the new building is complete a certificate of occupancy has been issued.
- Site Visits SEDCO hosted two site visits, a community luncheon community tour for project Two Face in June and July. SEDCO hosted a site visit for Project Eagle
- Proposals SEDCO submitted proposals for Projects Printing, Pros and Space. SEDCO also submitted follow up data for Project Two Face.

Real Estate:

 SEDCO began a review process for property near Progress Park. The site offers opportunities for a variety of commercial development scenarios.
