CALL TO ORDER, QUORUM DETERMINED, MEETING DECLARED OPEN, RECOGNITION OF GUESTS AND VISITORS

Mr. Kirkpatrick, Chairman of the Sherman Economic Development Corporation, called the meeting to order at 7:34 a.m., declared a quorum present, meeting declared open, recognition of guests and visitors.

EXECUTIVE SESSION

The Sherman Economic Development Corporation will hold an Executive Session pursuant to the provisions of the Open Meetings Law, Chapter 551, Government Code, Vernon's Texas Code Annotated, in accordance with the authority contained in the following sections:

RECONVENE OPEN MEETING AND CONSIDER ITEM DISCUSSED IN EXECUTIVE SESSION Mr. Kirkpatrick reconvened the open meeting at 8:20 a.m.

Mrs. Jones recommended the approval of a Sherman Economic Development Corporation Economic Development Performance Agreement with GlobiTech, Inc. The agreement states that GlobiTech will invest \$550,000 for building improvements and \$9,200,000 for equipment and create 12 jobs at its facility at 200 FM 1417 W, and SEDCO will provide an incentive of \$487,500 upon proof that the conditions have been met.

Motion to approve the Economic Development Performance Agreement with GlobiTech, Inc. was made by Mr. Sild and seconded by Mr. Douglass. Motion was approved unanimously.

Mr. Plotnik recommended the approval of a land agreement with Monarch Dev. Corp. for SEDCO to purchase 64.29 acres, located west of Panda Sherman Power, for \$450,000. The agreement states that the purchase is inclusive of \$15,000 to be paid upon execution of the agreement as earnest money to be held in escrow during the 60-day due diligence period.

Motion to approve the purchase of 64.29 acres from Monach Dev. Corp. was made by Mr. Willie Steele and seconded by Mr. Shields. Motion was approved unanimously.

PROPOSED FY 2017-2018 PROGRAM OF WORK & BUDGET

Mr. Plotnik discussed SEDCO's proposed FY 2017-2018 Program of Work and Budget which will be presented and considered for approval at the Annual Joint Meeting with the Sherman City Council on September 25, 2017.

2016-2017 PROGRAM OF WORK RESULTS & 2008-2017 RETURN ON INVESTMENT REPORT

Mr. Plotnik referred to the 2016-2017 Program of Work Results and the 2008-2017 Return on Investment Report, noting the total rate of return on the community's investment in economic development over 10 years is 125%.

OTHER BUSINESS

Mr. Willie Steele was presented with a plaque in appreciation for his service on the SEDCO Board of Directors from 2013-2017.
